1. LABRIE EQUIPMENT LTD. for Item 1 - seven (7) each Refuse Packer, 18 CY Side Loader (Ford C8000 chassis with low entry Wayne cab and Labrie 200 18CY side loader) at a cost of \$66,300.00 each, for a total cost of \$464,100.00; terms 18 20 days, plus sales tax.
2. T & J GARAGE, INC. for Item 2 - twelve (12) each Refuse Packer 37 CY side loader (Crane Carrier LET40B cab and chassis with Able 37 CY side loader and Cummins L10 engine) at a cost of \$97,675.63 each, for a total cost of \$1,172,107.56; terms net 20 days, plus sales tax.
