RESOLUTION NUMBER R- 269947

ADOPTED ON DEC 07 1987

WHEREAS, it has been proposed that Rule 18 of San Diego Municipal Code section 22.0101 [Permanent Rules of Council] be amended to provide some flexibility in the composition of the Committee on Rules, Legislation and Intergovernmental Affairs [herein "Rules"]; and

WHEREAS, an ordinance to amend Rule 18 is in the process of legislative enactment; and

WHEREAS, it is necessary to provide, pursuant to Rule 31, a temporary rule to address the issue of composition of the Rules Committee until such time as the Ordinance amending Rule 18 is effective; and

WHEREAS, such temporary rule will contain the same language as the ordinance, thereby permitting appointments to the Rules Committee to be made in a timely manner; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to San Diego Municipal Code section 22.0101, Rule 31, entitled "Temporary Rules" there is hereby established a temporary Rule 18.1 to read as follows:

There is a Committee on Rules, Legislation and Intergovernmental Relations (herein referred to as "Rules Committee") composed of five (5) voting members consisting of the Mayor, the Deputy Mayor and the three (3) chairpersons of

the other standing committees. In the event, however, that the Deputy Mayor is also a chairperson of a standing committee, the composition shall be the Mayor, Deputy Mayor, two (2) chairpersons of standing committees and the Councilmember appointed as chairperson of the Housing Commission. The Mayor shall be permanent chairperson and the Deputy Mayor shall be vice-chairperson of the Rules Committee.

BE IT FURTHER RESOLVED, that pursuant to Rule 31, such Temporary Rule 18.1 shall be in full force and effect until Permanent Rule 18 is amended by Council ordinance.
