WHEREAS, appointments to boards and commissions are governed procedurally by Council Policy No. 000-13; and

WHEREAS, the City Council adopted Ordinance No. O-16721 (New Series) on October 6, 1986 which amended Section 98.0301 of the San Diego Municipal Code relating to the membership composition of the San Diego Housing Commission; and

WHEREAS, said amendment, which shall be in full force and effect on November 4, 1986, provides that Councilmembers may be appointed as members of said Commission in those membership positions other than the two (2) low-income tenant positions; and

WHEREAS, it is now appropriate to appoint five (5) Councilmembers to said Commission, effective December 7, 1987; and

WHEREAS, it is also necessary to correct Resolution No. R-268708 for the purpose of rectifying a typographical error concerning expiration date of tenant-member Williams; NOW, THEREFORE,
