1. The City Council finds that the proposed use may adversely affect the neighborhood, the General Plan or the Community Plan and may be detrimental to the health, safety or general welfare of persons residing or working in the area. The project had not had the benefit of a thorough evaluation during the processing period, therefore the findings cannot be made that there would not be adverse affects on the neighborhoods, the General Plan and the Community Plan.
