

RESOLUTION NUMBER R- 269983

ADOPTED ON DEC 8 1987

WHEREAS, California Government Code Sections 65350 through 65362 set forth State requirements for the preparation, adoption and amendment of local general plans; and

WHEREAS, said State law and Council Policy 600-7 require that consistency be maintained among the City's General Plan and the various community plans and other official planning-related documents, subject to the limitation on the frequency of amendments to mandatory elements of the General Plan; and

WHEREAS, the planning actions identified in Planning Report No. 87-604, dated November 30, 1987, a copy of which is on file in the office of the City Clerk as Document No. RR- 269983, have been approved by the City Council between April 1, 1986 and October 31, 1987, but will not become effective until the General Plan is amended to be consistent with those actions; and


WHEREAS, the Planning Commission and the Council of The City of San Diego held public hearings on November 12, 1987, and December 8, 1987, respectively, to consider amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO to reflect those planning actions noted above; and

WHEREAS, the Planning Commission on November 12, 1987, adopted Resolution No. 0116-PC, thereby approving and recommending that the Council of The City of San Diego adopt the proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO will not become effective until adopted by the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO be, and the same is hereby adopted.
