APPROVING PARCEL MAP T.M. NO. 86-1039.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That said Council hereby finds that certain map surveyed by Lawrence E. Cole, Licensed Land Surveyor, entitled "PARCEL MAP T.M. NO. 86-1039 being a division of that portion of Pueblo Lot 1774 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County and is known as miscellaneous map No. 36, together with a portion of Lot 1, Block 4 of Muirlands Heights, according to map thereof No. 3023, filed in the office of the County Recorder of San Diego County," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of La Jolla Mesa Drive and said portion of a public street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said map and that said portion of a public street is hereby accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
