AN ORDINANCE APPLYING THE COMMUNITY PLAN IMPLEMENTATION OVERLAY ZONE (CPIOZ) TO THE MORENA REVITALIZATION AREA.

WHEREAS, the LINDA VISTA COMMUNITY PLAN was adopted by the City Council on July 12, 1983; and

WHEREAS, the Morena revitalization area is identified in the LINDA VISTA COMMUNITY PLAN with specific standards, criteria or guidelines for the design of development or for development intensity; and

WHEREAS, the Morena revitalization area is identified in the LINDA VISTA COMMUNITY PLAN where specific implementing legislation is necessary; and

WHEREAS, Criterion A of Municipal Code Section 101.0457.2 is satisfied; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the Morena revitalization area generally described as those properties bounded by Friars Road on the south, Pacific Highway on the west, Tecolote Road on the north and Gertrude Street, Savannah Street, Savannah Place, Mollie Street, Lauretta Street, Riley Street, and Benicia Street on the east, in the Linda Vista Community Plan area, in the City of San Diego, California, within the boundary of the district designated "Community Plan Implementation Overlay Zone" on Zone Map Drawing

No. C-750, filed in the office of the City Clerk as Document No. 00-17003, be, and it is hereby incorporated into Community Plan Implementation Overlay Zone (CPIOZ), as such zone is described and defined by San Diego Municipal Code Section 101.0457.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
