ORDINANCE NUMBER O- 17004 (New Series)

ADOPTED ON JAN 5 1988

AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16916-1, BY INCREASING THE CAPITAL IMPROVEMENTS PROGRAM BY INCREMENTALLY ADDING THE SUM OF \$839,812 TO CIP 90-245, CAPITAL OUTLAY RESERVE - GENERAL CONTINGENCY FUNDS, AS THE REVENUE IS RECEIVED IN ANTICIPATED REVENUES FROM THE FEDERAL GOVERNMENT FOR QUALIFIED PROJECT COSTS ON THE INGRAHAM STREET BRIDGE OVER FISHERMANS CHANNEL.

WHEREAS, The City of San Diego had anticipated funds from the federal government for qualified project costs on the Ingraham Street Bridge over Fishermans Channel; and

WHEREAS, this influx [reimbursement] of funds was inadvertently excluded in the resolutions in the Request for Council Action approved by Council on July 29, 1987, for the above specified improvement; and

WHEREAS, the present action is a technical financial correction and is deemed necessary to correct the budget figure;
NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO

OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16916-1, in order to increase the Capital Improvements Program by incrementally adding the sum of \$839,812 to CIP No. 90-245, entitled "Capital Outlay Reserve - General Contingency Funds," as said revenue is received in anticipated revenues from the federal government for qualified project costs on the Ingraham Street Bridge over Fishermans Channel.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
