

ORDINANCE NUMBER O- 17007 (NEW SERIES)

ADOPTED ON JAN 11 1988

AN ORDINANCE INCORPORATING PORTIONS OF ROSEDALE TRACT, MAP NO. 825, LOCATED EAST OF INTERSTATE 15, BETWEEN STATE ROUTE 52 (UNDER CONSTRUCTION) AND CLAIREMONT MESA BOULEVARD, IN THE TIERRASANTA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-IP AND HR ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0435.1 AND 101.0454, RESPECTIVELY, AND REPEALING ORDINANCE NO. 10864 (NEW SERIES), ADOPTED JULY 9, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Rosedale Tract, Map No. 825, located east of Interstate 15, between State Route 52 (under construction) and Clairemont Mesa boulevard, in the Tierrasanta Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-IP" and "HR" on Zone Map Drawing No. B-3860, filed in the office of the City Clerk as Document No. 769664, be, and it is hereby incorporated into the M-IP and HR Zones, as such zones are described and defined by San Diego Municipal Code Sections 101.0435.1 and 101.0454.

Section 2. That Ordinance No. 10864 (New Series), adopted July 9, 1972, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
