ORDINANCE NUMBER 0-17010 (NEW SERIES)

ADOPTED ON JANUARY 19, 1988

AN ORDINANCE INCORPORATING A PORTION OF POMPEII FARMS PER MAP NO. 1738, A PORTION OF SECTION 16, TOWNSHIP 14 SOUTH, RANGE 2 WEST, ALL IN THE CITY OF SAN DIEGO, LOCATED IMMEDIATELY EAST OF INTERSTATE 15, IN THE CARMEL MOUNTAIN RANCH COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE R-2500, CN AND CC ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0410, 101.0426 AND 101.0427, AND REPEALING ORDINANCE NO. O-16281 (NEW SERIES), ADOPTED OCTOBER 10, 1984, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Pompeii Farms per Map No. 1738, a portion of Rancho de los Penasquitos, and a portion of Section 16, Township 14 South, Range 2 West, located immediately east of Interstate 15, in the Carmel Mountain Ranch Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R-2500, CN and CC" on Zone Map Drawing No. C-686.2, filed in the office of the City Clerk as Document No. 769684, be, and it is hereby incorporated into the R-2500, CN and CC Zones, as such zones are described and defined by San Diego Municipal Code Sections 101.0410, 101.0426 and 101.0427.

Section 2. That Ordinance No. O-16281 (New Series), adopted October 10, 1984, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.
