AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16916-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF COUNCIL DISTRICT 7 (027) ONE (1.00) COUNCIL REPRESENTATIVE II POSITION; EXEMPTING SAID COUNCIL REPRESENTATIVE II POSITION FROM THE CLASSIFIED SERVICE; ESTABLISHING A SALARY RATE FOR SAID POSITION: AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$21,994 WITHIN THE GENERAL FUND 100 FROM THE UNALLOCATED RESERVE (605) TO COUNCIL DISTRICT 7 (027) FOR THE ABOVE POSITION, ALLOCATING \$16,664 TO PERSONNEL SERVICES, \$3,830 TO FRINGE BENEFITS, AND \$1,500 TO NON-PERSONNEL EXPENSE.

WHEREAS, the Councilmember in District 7 has requested the addition of one (1.00) Council Representative II position to the District 7 budget; and

WHEREAS, in connection therewith, it is further requested that the new position be exempted from the Classified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial" employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on December 16, 1987 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is necessary to amend the annual appropriation ordinance to effectuate said addition of one position and exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as amended and adopted therein, by adding to the personnel authorization schedule of Council District 7 (027) one (1.00) Council Representative II position.

Section 2. That pursuant to section 117(a)17 of the City
Charter, after having been reviewed and commented upon favorably
by the Civil Service Commission on December 16, 1987, the Council
Representative II position is hereby exempted from the Classified
Service and declared to be in the Unclassified Service of The
City of San Diego.

Section 3. As a schedule of compensation for the above unclassified position created in section 1. and 2. hereof, the salary rate set forth in Salary Rates 07.3, 07.4 and 07.5 of the Table of Classifications and Standard Salary Rates under

Managerial Category B, contained in Exhibit C to Ordinance No. 16867 (New Series), be and the same is hereby adopted.

Section 4. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$21,994 from the Unallocated Reserve (605) to Council District 7 (027) and increase the budget appropriation for Council District 7 (027) by said amount, for the purpose of fully funding the above newly-authorized positions for the remainder of fiscal year 1988, allocating \$16,664 to Personnel Services, \$3,830 to Fringe Benefits, and \$1,500 to Non-Personnel expenses.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
