AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16916-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF COUNCIL DISTRICT 4 (024) BY DELETING ONE (1.00) COUNCIL SECRETARY POSITION AND BY ADDING ONE (1.00) COUNCIL REPRESENTATIVE I POSITION; EXEMPTING SAID COUNCIL REPRESENTATIVE I POSITION FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE FOR SAID POSITION.

WHEREAS, Council District 4 has requested the deletion of one (1.00) Council Secretary position from its personnel authorization in the fiscal year 1987-88 budget; and

WHEREAS, the Councilmember in District 4 has requested, in lieu thereof, the addition of one (1.00) Council Representative I position to its personnel allocation; and

WHEREAS, it has been requested that the newly assigned Council Representative I position be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial" employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on December 16, 1987 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said deletion and additional position; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as amended and adopted therein, by deleting one (1.00) Council Secretary position and by adding one (1.00) Council Representative I position to the personnel authorization schedule of Department 024, Councilmanic District 4.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on December 16, 1987, the Council Representative I position is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the above unclassified position created in section 1. and 2. hereof, the salary rate set forth in Salary Rates 07.0, 07.1 and 07.2 of the

Table of Classifications and Standard Salary Rates under
Managerial Category A, contained in Exhibit C to Ordinance No.
16867 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force
immediately upon its adoption after two (2) public hearings,
pursuant to the authority contained in sections 16, 17 and 71 of
the Charter of The City of San Diego.


