AN ORDINANCE AMENDING ORDINANCE NO. 16867 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1987-88" BY AMENDING EXHIBIT C THERETO TO CREATE AND ADD A NEW CLASSIFICATION ENTITLED "WASTE MANAGEMENT DIRECTOR" IN THE UNCLASSIFIED SERVICE AND PLACING SAID NEWLY CREATED POSITION IN THE EXECUTIVE CATEGORY, CLASSIFICATION RANGE "EXECUTIVE IV," WITH SALARY RANGE 04.0, 04.1, AND 04.2 AND 04.3.

WHEREAS, it has been recommended by the City Manager in City Manager Report No. 88-80, dated January 29, 1988, that a new department of the City be established to contain all City of San Diego functions relating to trash, specifically including Refuse Collection, Refuse Disposal, Litter Control and Resource Conservation and Management; and

WHEREAS, it is submitted that such action will isolate those related functions in one department and provide for a more efficient and responsible operation; and

WHEREAS, the background and discussion of the matter is set forth in City Manager Report No. 88-80 which was considered by the Rules Committee on February 3, 1988; and

WHEREAS, the Rules Committee, after an in-depth discussion of the concept and recommendation, approved the matter by a 4-1 vote, with District 1 opposing; and

WHEREAS, a companion ordinance has been prepared to establish in the Municipal Code the Department of Waste Management as a department of the City; and

WHEREAS, it is now necessary and recommended that the annual salary ordinance be amended to provide for the setting forth of a department director's position in Executive Category IV; and


WHEREAS, the matter is forwarded to the full Council for such amendatory action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 16867 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1987-88" be and the same is hereby further amended by amending Exhibit C thereto by creating and adding a new class, entitled "WASTE MANAGEMENT DIRECTOR" in the Unclassified Executive Category IV group at a salary range of 04.0, 04.1, 04.2 and 04.3.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
