**AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2,
DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 102.0406.10 RELATING TO
COLLECTION AND DISTRIBUTION OF FEES -
MAINTENANCE OF PARK SERVICE DISTRICTS MAP.**

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 2, Division 4, of the San Diego Municipal Code be and the same is hereby amended by amending Section 102.0406.10 to read as follows:

**SEC. 102.0406.10 COLLECTION AND DISTRIBUTION OF
FEES - MAINTENANCE OF PARK
SERVICE DISTRICTS MAP**

1. Prior to the acceptance of a final map, any required fees shall have been paid to the City. Any land to be contributed for purposes outlined in this section shall be deeded to the City and shown on such map.

2. The City Manager shall be responsible for the following:

a. Distribution of fees as set forth in Section 102.0406.06 herein; and

b. Maintenance of and revisions to the map entitled, "Population-Based Park Service Districts of The City of San Diego," which map

shall be presented to the City Council for review
and ratification whenever changes are proposed by
the City Manager.

Section 2. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage.
