C-670.4, C-671.1, C-676.4, C-679.2, C-683.1, C-698 and C-694, and described in the appended boundary description filed in the office of the City Clerk. Sections 103.0600 through 103.0618 shall apply to each precise plan within the North City West Community Plan area when adopted by the City Council.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
