AN ORDINANCE AMENDING ORDINANCE NO. O-16855 (NEW SERIES), ADOPTED MAY 4, 1987, LIMITING THE ISSUANCE OF BUILDING PERMITS AND DEMOLITION PERMITS IN PORTIONS OF UPTOWN, TO EXTEND THE EFFECTIVE DATE ONE YEAR AND TO REQUIRE CONSISTENCY WITH THE REVISED UPTOWN COMMUNITY PLAN.

WHEREAS, on JAN 14 1988, the Planning Commission approved and recommended to the City Council that Ordinance No. 0-16855 (New Series), adopted May 4, 1987, concerning the Uptown Community Plan area, be extended one year; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1. of Ordinance No. 0-16855 (New Series), adopted May 4, 1987, is amended, to read as follows:

Section 1. Within the area known as the Uptown
Community Plan area and generally bounded by Interstate
5 on the west and south, Interstate 8 on the north and
Park Boulevard and Balboa Park on the east, as shown on
Zone Map Drawing No. C-734, a copy of which is on file
in the office of the City Clerk as Document No.

00-16855-1, no building permits shall be issued for
construction of any structure if the total number of
existing and proposed dwelling units of any one project
exceeds eleven units, or if the residential density for
all proposed and existing buildings on the premises

exceeds one dwelling unit for every 3000 square feet of lot area, unless a Planned Infill Residential Development Permit, Planned Commercial Development Permit, or Conditional Use Permit is obtained, except as otherwise provided by this ordinance. The Planned Residential Infill Development ordinance standards will be used for all projects. For the purposes of this ordinance, the density of the project shall not exceed the density as prescribed in the adopted community plan or the underlying zoning, whichever is less.

Section 2. That Section 9. of Ordinance No. O-16855 (New Series), adopted May 4, 1987, which expires on May 4, 1988, be and the same is hereby amended for the purpose of extending the effective date for one year, to read as follows:

Section 9. The provisions of this ordinance shall remain in force and effect until May 4, 1989, or until the zoning implementation for the revised Uptown Community Plan is in effect, whichever occurs first, unless it is extended by act of this City Council or is superseded by new legislation.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
