AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16916-1, AS AMENDED AND ADOPTED THEREIN, BY INCREASING THE CAPITAL IMPROVEMENTS PROGRAM BY THE SUM OF \$120,000, SAID SUM TO BE DERIVED FROM THE DONATIONS IN THE DEPOSIT TRUST FUND [63021] AND ALLOCATING SAID \$120,000 TO CIP NO. 37-183, ENTITLED SAN YSIDRO BOYS CLUB.

WHEREAS, The City of San Diego purchased the San Ysidro Boys Club for renovation and intended use by the community; and

WHEREAS, the City paid \$100,000 in CDBG funds for said acquisition; and

WHEREAS, Mrs. Irving Salomon contributed \$100,000 in the memory of her husband for purposes of renovating said facility; and

WHEREAS, the Price Charitable Remainder Trust and Weingart Foundation contributed \$10,000 each for the same purpose; and

WHEREAS, the City accepted said donations and the City Auditor and Comptroller placed said \$120,000 in the "San Ysidro Boys Club Trust Fund" as a repository for the funds prior to the intended purpose of renovation; and


WHEREAS, it is now desirable and appropriate to appropriate and allocate said funds to the applicable CIP Project for expenditure in pursuance of the intention of the donors; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as amended and adopted therein, by increasing the Capital Improvements Program by the sum of \$120,000, said sum to be derived from the donations in the deposit trust fund [63021] and allocating said \$120,000 to CIP No. 37-183, entitled "San Ysidro Boys Club."

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
