WHEREAS, the City accepted said donations and the City
Auditor and Comptroller placed said \$120,000 in the "San Ysidro
Boys Club Trust Fund" as a repository for the funds prior to the
intended purpose of renovation; and

WHEREAS, it is now desirable and appropriate to appropriate and allocate said funds to the applicable CIP Project for expenditure in pursuance of the intention of the donors; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as amended and adopted therein, by increasing the Capital Improvements Program by the sum of \$120,000, said sum to be derived from the donations in the deposit trust fund [63021] and allocating said \$120,000 to CIP No. 37-183, entitled "San Ysidro Boys Club."
