AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0245 RELATING TO RECORDATION OF VARIANCES, PERMITS OR ENTITLEMENTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 101.0245, to read as follows:

SEC. 101.0245 RECORDATION OF VARIANCES, PERMITS OR **ENTITLEMENTS**

Upon approval of a variance of any of the permits or entitlements listed in this section, all of which are found to constitute instruments affecting title to or possession of real property, the variance, permit, or entitlement shall be recorded in the office of the County Recorder of San Diego County.

Section 2. This ordinance shall become effective on October 17, 1988, provided that by such date the Local Coastal Program of The City of San Diego (including Coastal Commission recommended rezonings) has been: (i) accepted by the Executive Director of the Coastal Commission; (ii) is finally and effectively certified by the Coastal Commission; and (iii) coastal development permit

issuing responsibility is authorized by the Coastal Commission to be undertaken by The City of San Diego. In the event the aforesaid conditions are not met, this ordinance is null and void.
