AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16916-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE CITY CLERK'S DEPARTMENT (035) BY DELETING THE POSITIONS OF ELECTIONS OFFICER AND RECORDS MANAGEMENT OFFICER AND ADDING IN LIEU THEREOF TWO (2.00) DEPUTY DIRECTORS; EXEMPTING SAID TWO (2.00) NEW POSITIONS FROM THE CLASSIFIED SERVICE PURSUANT TO SECTION 117(a)17 OF THE SAN DIEGO CHARTER AFTER REVIEW AND CONSIDERATION OF THE UNFAVORABLE COMMENT THEREON BY THE CIVIL SERVICE COMMISSION; AMENDING THE ANNUAL SALARY ORDINANCE NO. 16867 (NEW SERIES) BY INCORPORATING SAID NEW TITLES OF DEPUTY DIRECTOR FOR LEGISLATIVE SERVICES AND ELECTIONS AND DEPUTY DIRECTOR FOR RECORDS MANAGEMENT AND INFORMATION INTO EXHIBIT C THEREOF; AND ESTABLISHING SALARY RATES THEREFOR.

WHEREAS, the City Clerk has requested the creation of three (3.00) new unclassified positions in the Clerk's office; and

WHEREAS, said positions are proposed as a result of an anticipated reorganization within the Clerk's office, as set forth more fully in the City Clerk's Report to the Mayor and City Council No. CC-87-20, dated December 30, 1987; and

WHEREAS, the three (3.00) newly proposed positions were intended to replace three (3.00) existing positions as follows: Elections Officer to Deputy Director for Legislative Services and Elections, Records Management Officer to Deputy Director for

Records Management and Information, and Associate Administrative Analyst to Assistant to the City Clerk for Administration and Systems Support; and

WHEREAS, it had been requested that the three (3.00) new positions be exempted from the Classified Service and placed in the Unclassified Service of The City of San Diego; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering department policies and programs" may be exempted from Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on December 16, 1987 and unanimously concluded that the positions did not meet the Charter criterion for exemption and commented unfavorably to the request in its Report to the Mayor and City Council, dated January 19, 1988, attached hereto as Attachment A; and

WHEREAS, after consideration of the report and unfavorable recommendation of the Civil Service Commission, it is the decision of the Council to exempt only two (2.00) of the positions from the Classified Service in accordance with the justification set forth in City Clerk Report No. CC-87-20, eliminating from any consideration the change to the Associate Administrative Analyst position; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance and salary ordinance to effectuate said deletions and additions; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as amended and adopted therein, by deleting one (1.00) Elections Officer position and one (1.00) Records Management position, and by adding one (1.00) Deputy Director for Legislative Services and Elections position and one (1.00) Deputy Director for Records Management and Information position to the personnel authorization schedule of Department 035, City Clerk.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon unfavorably by the Civil Service Commission on December 16, 1987, as not meeting the Charter criterion for exemption from the Classified Service, and after having considered and reviewed the report thereon from the Civil Service Commission, attached hereto as Attachment A, the newly proposed positions cited above are hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.


Section 3. That the newly created positions set forth in section 1 above be and they are hereby included in Exhibit C to Ordinance No. 16867 (New Series), the annual salary ordinance, for inclusion in the Managerial Category C.

Section 4. As a schedule of compensation for the two (2.00) unclassified positions created in the above sections hereof, the salary rates set forth in Salary Rates 07.7, 07.8 and 07.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, contained in Exhibit C to Ordinance No. 16867 (New Series), be and the same are hereby adopted.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

This ordinance amends the annual appropriation ordinance to add two new positions to the City Clerk's department [two Deputy Directors] and deletes therefrom two positions [one Elections Officer and one Records Management Officer]. The ordinance also exempts the two (2.00) new positions from the Classified Service after a review by the Council of an unfavorable comment thereon by the Civil Service Commission pursuant to Charter section 117 (a) 17. The ordinance further amends the annual salary ordinance for the purpose of incorporating the two (2.00) new positions in the listing of classifications of unclassified managerial titles set forth in Exhibit C as Deputy Director for Legislative Services and Elections and Deputy Director for Records Management and Information. Finally, the ordinance establishes a rate of pay for the two (2.00) new positions in managerial Category C at 07.7, 07.8, and 07.9.
