AN ORDINANCE INCORPORATING A 51.8-ACRE PARCEL, LOCATED SOUTH OF THE INTERSECTION OF CARMEL MOUNTAIN ROAD AND SUNDANCE AVENUE AND NORTHWEST OF THE INTERSECTION OF PARK VILLAGE ROAD AND BRICKELLA STREET, DESCRIBED AS THE SOUTHEAST 1/4 OF THE SOUTHWEST 1/4 AND A PORTION OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 13, TOWNSHIP 14 SOUTH, RANGE 3 WEST, SBM, IN THE PENASQUITOS EAST COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-5000 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407, AND REPEALING ORDINANCE NO. 0-8858 (NEW SERIES), ADOPTED JULY 18, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three (3) years of the effective date of this ordinance incorporating a 51.8-acre parcel, located south of the intersection of Carmel Mountain Road and Sundance Avenue and Northwest of the intersection of Park Village Road and Brickella Street, described as the Southeast 1/4 of the Southwest 1/4 and a portion of the Southwest 1/4 of the Southeast 1/4 of Section 13, Township 14 South, Range 3 West, SBM, in the Penasquitos East Community Plan area, in the City of San Diego, California, designated "R1-5000" on Zone Map Drawing No. B-3830, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the

installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0407 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into R1-5000 Zone, as described and defined by Section 101.0407, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3830, filed in the office of the City Clerk as Document No. <u>00-17084</u>. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1. of this ordinance, Ordinance No. 0-8858 (New Series), adopted July 18, 1963, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage.
