ORDINANCE NUMBER 0-17092 (NEW SERIES) ADOPTED ON MAY 161988

AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 4, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 84.16 RELATING TO TRESPASSING AT CEMETERY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 4, of the San Diego Municipal Code be and the same is hereby amended by adding Section 84.16 to read as follows:

SEC. 84.16 TRESPASSING ON MT. HOPE CEMETERY

It shall be unlawful for any person to come onto Mt. Hope Cemetery property for any purposes other than those involving burials or funerals or involving the visiting of a gravesite at the cemetery.

Signs shall be posted at intervals not less than three to the mile along all exterior boundaries and at all roads and sidewalks entering the cemetery, which signs shall contain the following language:

"It is unlawful for any person to come onto

Mt. Hope Cemetery property for purposes other than
those involving burials or funerals or the visiting
of gravesites."

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
