**AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 6,
DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 96.0404 RELATING TO USE OF
FEES COLLECTED.**

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 6, Division 4, of the San Diego Municipal Code be and the same is hereby amended by amending Section 96.0404, to read as follows:

SEC. 96.0404 USE OF FEES COLLECTED

Fees collected pursuant to the provisions of this Article, together with any earned interest thereon, shall be deposited in a special fund with a separate revenue and expense account established for park and recreational purposes. Expenditures from said fund shall be made only for park and recreational facilities within areas from which they were collected. Expenditures may be for: (1) the City purchase of land and the construction of facilities, (2) the purchase of already constructed facilities from public agencies or private parties, (3) the rehabilitation of existing park or recreational facilities only when such rehabilitation would serve expanded needs or demographic changes at existing parks or provide new additional equipment

expanded use of the park or (4) to reimburse those who may have donated land and constructed improvements to the extent of the value of such land and improvements in excess of their proportionate responsibility.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
