adopted MAY 9 1988 shall be added to Council District
No. 5, which district is shown and delineated on that certain map
on file in the office of the City Clerk as Document No. 742458,
showing the boundary line of said district, and which map was
approved by Ordinance No. 10990 (New Series) of the ordinances of
The City of San Diego, adopted February 6, 1973.

Section 2. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage.
