ADOPTED ON JUN 13 1988

AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16916-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE FIRE DEPARTMENT (120), FIRE PREVENTION PROGRAM (12030) POSITIONS AS FOLLOWS: 13.35 FIRE PREVENTION INSPECTOR II, 2.00 FIRE PREVENTION SUPERVISORS, AND 1.00 INTERMEDIATE TYPIST, ALL RELATED TO THE HAZARDOUS MATERIALS INSPECTION PROGRAMS.

WHEREAS, the City Manager has recommended an increase in fees for the Hazardous Materials Inspection Program (CEDMAT) and a concurrent increase in Fire Department personnel of 16.35 positions for said expanded inspection program; and

WHEREAS, the background, discussion and recommendations for amending the budget for the new personnel and related expenses are set forth in detail in City Manager's Report No. 88-258, dated May 13, 1988; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to add to the personnel authorization of the Fire Department (120), Fire Prevention Program (12030) the above specified personnel; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as amended and adopted therein, by adding to the personnel authorization schedule of the Fire Department (120), Fire Prevention Program (12030) the following new positions for programs as indicated:

Hazardous Materials Inspections Program

13.35 Fire Prevention Inspector II
2.00 Fire Prevention Supervisors
1.00 Intermediate Typist

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
