AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY INCREASING THE CAPITAL IMPROVEMENTS PROGRAM BY THE SUM OF \$100,000 AND ALLOCATING THE AFORESAID \$100,000 TO CIP NO. 52-368 ENTITLED PENASQUITOS DRIVE - ALMAZON STREET TO CUCA STREET, SAID FUNDS TO COME FROM FACILITIES BENEFIT ASSESSMENT FUND 79004.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16916 (New Series), as amended, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 1987-1988 and Appropriating the Necessary Money to Operate the City for Said Fiscal Year" is hereby amended to increase the Capital Improvements Program by the sum of \$100,000 and allocating the aforesaid \$100,000 to CIP No. 52-368 entitled PENASQUITOS DRIVE - ALMAZON STREET TO CUCA STREET, said funds to come from Facilities Benefit Assessment Fund 79004.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.


