AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY INCREASING THE CAPITAL IMPROVEMENTS PROGRAM BY ADDING \$700,002 (\$144,000 FROM BALBOA PARK ADMINISTRATION BUILDING - SAFCO GRANT FUND; \$135,000 FROM BALBOA PARK ADMINISTRATION BUILDING - HISTORICAL PRESERVATION GRANT FUND NO. 1; \$90,000 FROM BALBOA PARK ADMINISTRATION BUILDING - HISTORICAL PRESERVATION GRANT FUND NO 2; AND \$331,002 FROM BALBOA PARK ADMINISTRATION BUILDING - MUSEUM OF MAN PRIVATE FUND).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16916 (New Series), as amended, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 1987-1988 and Appropriating the Necessary Money to Operate the City for Said Fiscal Year" is hereby amended to increase the Capital Improvements Program by adding \$700,002 (\$144,000 from Balboa Park Administration Building - SAFCO Grant Fund; \$135,000 from Balboa Park Administration Building - Historical Preservation Grant Fund No. 1; \$90,000 from Balboa Park Administration Building - Historical Preservation Grant Fund No. 2; and \$331,002 from Balboa Park Administration Building - Museum of Man Private Fund).

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
