AN ORDINANCE INCORPORATING PROPERTIES LOCATED ALONG THE NORTH SIDE OF WEST POINT LOMA BOULEVARD, EAST OF NIMITZ BOULEVARD AND WEST OF FAMOSA BOULEVARD, IN THE OCEAN BEACH PRECISE PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1750 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0410, AND REPEALING ORDINANCE NO. 4407 (NEW SERIES), ADOPTED MAY 16, 1950, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That properties located along the north side of West Point Loma Boulevard, east of Nimitz Boulevard and west of Famosa Boulevard, in the Ocean Beach Precise Plan area, in the City of San Diego, California, within the boundary of the district designated "R-1750" on Zone Map Drawing No. B-3882, filed in the office of the City Clerk as Document No. O-17131 be, and it is hereby incorporated into R-1750 Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0410.

Section 2. That Ordinance No. 4407 (New Series), adopted May 16, 1950, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage, and no building permits for development inconsistent with the provisions


