ADOPTED ON SEP 12 1988

AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF OF THE PLANNING DEPARTMENT 065, IN GENERAL FUND 100, BY EXEMPTING ONE (1) CITY ARCHITECT POSITION FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Planning Department has requested the exemption from the Classified Service of one (1) City Architect position which is already authorized; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on June 2, 1988 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said exemption from the Classified Service; NOW, THEREFORE


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That after receiving the June 2, 1988 review and favorable comment thereon by the Civil Service Commission, pursuant to Charter section 117(a)(17), that Ordinance No. O-17122 (New Series), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17122-1, as adopted and amended therein, by amending the personnel authorization schedule of Department 065, Planning Department, General Fund 100, to reflect the exemption of one (1) City Architect position from the Classified Service and its inclusion in the Unclassified Service of The City of San Diego.

Section 2. As a schedule of compensation for the above unclassified position, the salary rate set forth in Salary Rates 03.0, 03.1 and 03.2 of the Table of Classifications and Standard Salary Rates in the Executive Category III, contained in Exhibit C to Ordinance No. O-17098 (New Series), dated May 31, 1988, be and the same is hereby adopted.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
