AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16916-1, BY ADDING TO THE FISCAL YEAR 1988 CAPITAL IMPROVEMENTS A NEW PROGRAM C.I.P. NO. 39-108, ENTITLED "OPEN SPACE VERNAL POOL PRESERVATION ACQUISITION"; DIRECTING THE AUDITOR AND COMPTROLLER TO INCREASE THE CIP PROGRAM FUNDING BY APPROPRIATING AND ALLOCATING THE SUM OF \$750,000 IN GENERAL REVENUE SHARING FUNDS (18014) TO THE NEWLY ESTABLISHED C.I.P. NO. 39-108; AUTHORIZING THE AUDITOR AND COMPTROLLER TO EXPEND THE SUM OF \$750,000 IN GENERAL REVENUE SHARING FUNDS (18014) FROM C.I.P. NO. 39-108 AND THE SUM OF \$457,000 FROM THE VERNAL POOL PRESERVATION FUND (10570) FOR SAID C.I.P. PROGRAM.

WHEREAS, the City's Vernal Pool Preservation was initiated in 1980 and a Preservation Fund (10570) was established, collecting fees as partial mitigation for the loss of vernal pool habitats through proposed developments; and

WHEREAS, the City now contemplates condemnation action to acquire 18.72 acres of land (Lopez Ridge properties) for open space vernal pool preservation and right-of-way for the proposed Calle Cristobal Street Project; and

WHEREAS, the total acquisition costs of the land is estimated to be \$1.176 million; and

WHEREAS, unappropriated General Revenue Sharing Funds have been set aside in a contingency reserve for such unforeseen purposes; and

WHEREAS, from said reserve, the sum of \$750,000 is proposed for allocation to the vernal pool preservation acquisition, which is established as a new C.I.P. Program No. 39-108; and

WHEREAS, the sum identified for right-of-way acquisition would be reimbursed by the Calle Cristobal assessment district or by the developer; and

WHEREAS, it is recommended to the Council that this action be approved to move forward with the declared intent and purpose of vernal pool preservation; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That ordinance No. 0-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and it is hereby further amended by amending Document No. 00-16916-1, as amended, to add to the fiscal year 1988 Capital Improvements Program a new project, C.I.P. No. 39-108, entitled "Open Space Vernal Pool Preservation Acquisition."

Section 2. That the Auditor and Comptroller be and he is hereby directed to increase the funding of the C.I.P. Program by appropriating and allocating the sum of \$750,000 in General Revenue Sharing Funds (18014) to the newly established C.I.P. No. 39-108.

Section 3. That the Auditor and Comptroller be and he is hereby further authorized to expend the above sum of \$750,000 in General Revenue Sharing Funds (18014) from C.I.P. No. 39-108 for

the purposes established therein and the further sum of \$457,000 from the Vernal Pool Preservation Fund (10570) for purposes of C.I.P. No. 39-108.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
