ADOPTED ON SEP 20 1988

AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY INCREASING THE FISCAL YEAR 1989 CAPITAL IMPROVEMENTS PROGRAM BY \$1,925,000; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER TO SAID CAPITAL IMPROVEMENTS PROGRAM FOR CIP PROJECT 37-417, ENTITLED "CITY OPERATIONS BUILDING - PERMIT CENTER CONSTRUCTION" THE SUMS OF \$425,000 FROM THE GENERAL FUND 100, UNALLOCATED RESERVE (605) AND \$1,500,000 FROM THE BUILDING INSPECTION ENTERPRISE FUND 41300, UNAPPROPRIATED FUND BALANCE (1300).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, as amended and adopted therein, by increasing the Fiscal Year 1989 Capital Improvements Program by the sum of \$1,925,000.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer to the Capital Improvements Program for allocation to CIP Project No. 37-417, entitled "City Operations Building - Permit Center Construction" the sums of

\$425,000 from the General Fund 100, Unallocated Reserve (605) and \$1,500,000 from the Building Inspection Enterprise Fund 41300, Unappropriated Fund Balance (1300).

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

This ordinance amends the annual appropriation ordinance by increasing the Capital Improvements Program in the amount of \$1,925,000 and allocating said sum to CIP Project No. 37-417, entitled "City Operations Building-Permit Construction Center." The ordinance further authorizes the Auditor and Comptroller to transfer said \$1,925,000 into the Capital Improvements Program from the following sources: \$425,000 from the General Fund 100, Unallocated Reserve (605) and \$1,500,000 from the Building Inspection Enterprise Fund 41300, Unappropriated Fund Balance (1300).
