ORDINANCE NUMBER O- 17147 (NEW SERIES)

ADOPTED ON SEP 26 1988

AN ORDINANCE INCORPORATING VARIOUS PROPERTIES LOCATED IN AN AREA GENERALLY BOUNDED BY NORTH CITY WEST, DEL MAR HEIGHTS AND THE CITY OF DEL MAR TO THE NORTH, PENASQUITOS EAST AND MIRA MESA TO THE EAST, UNIVERSITY CITY TO THE SOUTH AND TORREY PINES STATE RESERVE AND THE PACIFIC OCEAN TO THE WEST, IN THE TORREY PINES, UNIVERSITY, MIRA MESA AND PENASQUITOS EAST COMMUNITY PLAN AREAS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO FLOODWAY (FW) AND FLOODPLAIN FRINGE (FPF) OVERLAY ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0403 AND 101.0403.1, AND REPEALING ORDINANCE NOS. 5591 (NEW SERIES), ADOPTED MAY 14, 1953, 8341 (NEW SERIES), ADOPTED AUGUST 25, 1960, 8485 (NEW SERIES), ADOPTED JUNE 22, 1961, 8858 (NEW SERIES), ADOPTED JULY 18, 1963, 9026 (NEW SERIES), ADOPTED MAY 28, 1964, 9030 (NEW SERIES), ADOPTED JUNE 4, 1964, 10013 (NEW SERIES), ADOPTED APRIL 10, 1969, 10240 (NEW SERIES), ADOPTED FEBRUARY 19, 1970, 10580 (NEW SERIES), ADOPTED MAY 13, 1971, 10606 (NEW SERIES), ADOPTED JUNE 24, 1971, 10884 (NEW SERIES), ADOPTED AUGUST 8, 1972, 10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, 11088 (NEW SERIES), ADOPTED JUNE 21, 1973, 11176 (NEW SERIES), ADOPTED DECEMBER 11, 1973, 11768 (NEW SERIES), ADOPTED FEBRUARY 11, 1976, O-12689 (NEW SERIES), ADOPTED JULY 2, 1979 AND 13455, APPROVED FEBRUARY 15, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That various properties, located in an area generally bounded by North City West, Del Mar Heights and the City of Del Mar to the north, Penasquitos East and Mira Mesa to the east, University City to the south and Torrey Pines State

Reserve and the Pacific Ocean to the west, in the Torrey Pines, University, Mira Mesa and Penasquitos East Community Plan areas, in the City of San Diego, California, within the boundaries of the districts designated "Floodway (FW) and Floodplain Fringe (FPF) Overlay" on Zone Map Drawing No. 753.1, Sheets 1-3, filed in the office of the City Clerk as Document No. O-17147, be, and they are hereby incorporated into Floodway (FW) and Floodplain Fringe (FPF) Overlay Zones, as such zones are described and defined by San Diego Municipal Code Sections 101.0403 and 101.0403.1.



That Ordinance Nos. 5591 (New Series), adopted May 14, 1953, 8341 (New Series), adopted August 25, 1960, 8485 (New Series), adopted June 22, 1961, 8858 (New Series), adopted July 18, 1963, 9026 (New Series), adopted May 28, 1964, 9030 (New Series), adopted June 4, 1964, 10013 (New Series), adopted April 10, 1969, 10240 (New Series), adopted February 19, 1970, 10580 (New Series), adopted May 13, 1971, 10606 (New Series), adopted June 24, 1971, 10884 (New Series), adopted August 8, 1972, 10936 (New Series), adopted October 5, 1972, 11088 (New Series), adopted June 21, 1973, 11176 (New Series), adopted December 11, 1973, 11768 (New Series), adopted February 11, 1976, O-12689 (New Series), adopted July 2, 1979 and 13455, approved February 15, 1932, of the ordinances of The City of San Diego be and they are repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
