THREE (3.00) BUILDING INSPECTOR II AND ONE
(1.00) ADMINISTRATIVE AIDE II, FOR PURPOSES OF
STRENGTHENING THE CITY'S HOUSING CODE

WHEREAS, on August 3, 1988, the Public Services and Safety Committee concurred with the City Manager's recommendations, set forth in Report No. 88-388, dated July 39, 1988, relating to strengthening the City's housing code enforcement efforts; and

ENFORCEMENT PROGRAM.

WHEREAS, those recommendations included the addition to the Building Inspection Department's Housing Inspection Division three (3.00) Building Inspector II (Housing) positions and (1.00) Administrative Aide II position; and

WHEREAS, it is necessary to increase the departmental budget by \$86,588 for Personnel expenses and \$42,673 for Non-Personnel expenses, said funds to be provided by increased fees; and

WHEREAS, such funds are presently available in the Building
Inspection Enterprise Fund 41300 retained earnings to cover said
costs until the increased fees are collected; and

WHEREAS, it is now necessary and appropriate to amend the annual appropriation ordinance to accommodate the above-stated amendments; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, as amended and adopted therein, by adding to the personnel authorization schedule of the Building Inspection Department (1300), Housing Inspection Division, the following new positions for programs as indicated:

## HOUSING CODE ENFORCEMENT PROGRAM

- 3.00 Building Inspector II (Housing)
- 1.00 Administrative Aide II

Section 2. That the Auditor and Comptroller be and he is hereby authorized to increase the Building Inspection Department budget by the sums of \$86,588 for Personnel services and \$42,673 for Non-Personnel expenses, said funds to be provided by increased fees; provided that necessary funds be made available from Building Inspection Enterprise Fund (41300) retained earnings to cover costs incurred until increased fees are collected and repaid to said fund.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
