AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY ESTABLISHING CAPITAL IMPROVEMENT PROJECT NO. 52-438.0, "PRELIMINARY ROAD DESIGN - SR 905 CORRIDOR," TO PERMIT THE DESIGN OF A NEW ROADWAY; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$115,000 FROM OTAY MESA FACILITIES DEVELOPMENT FUND, NO. 39062, TO C.I.P. NO. 52-438.0, FOR THE PURPOSE OF FUNDING C.I.P. NO. 52-438.0, "PRELIMINARY ROAD DESIGN - SR 905 CORRIDOR."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, as amended and adopted therein, by establishing Capital Improvements Project No. 52-438.0, entitled "Preliminary Road Design - SR 905 Corridor" for the purpose of funding preliminary road design agreements for the construction of the SR 905 Corridor.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$115,000 of Otay Mesa Facilities Development funds, No. 39062, to C.I.P. No. 52-438.0,

"Preliminary Road Design - SR 905 Corridor," for the purpose of funding initial design work for the heretofore newly established C.I.P. No. 52-438.0.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
