ADOPTED ON SEP 27 1988

AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, TO PROVIDE AUTHORIZATION TO THE AUDITOR AND COMPTROLLER TO APPROPRIATE AND ALLOCATE, AND THEREAFTER TRANSFER PRIVATE DONATIONS OF FUNDS [\$1 MILLION FROM JOAN KROC] AND OTHER FUTURE GIFTS, WITH INTEREST THEREON, TO SAN DIEGO FESTIVALS, INC., FOR EXPENDITURE IN ACCORDANCE WITH THE OPERATING BUDGET APPROVED BY COUNCIL.

WHEREAS, funds for support of the San Diego Arts Festival: Treasures of the Soviet Union are provided by a joint public-private partnership; and

WHEREAS, Ms. Joan Kroc has generously donated to the City the sum of \$1,000,000+ for said arts/cultural festivals; and

WHEREAS, the City Manager recommended in his Report No. 88-436, with attachments thereto dated August 31, 1988, that this donation and any others forthcoming, with interest thereon, be appropriated by the Auditor and Comptroller and then transferred to the San Diego Festivals, Inc., for expenditure in accordance with its approved operating budget; and

WHEREAS, San Diego Festivals, Inc. is to be established by Council ordinance as a nonprofit corporation in order to facilitate acceptance of private donations and expenditure of such private donations in conjunction with public funds, all

related to the 1989 San Diego Arts Festival: Treasures of the Soviet Union; and

WHEREAS, the Rules Committee, at its regular meeting of September 7, 1988, unanimously approved the recommendation of the Manager and directed the matter be forwarded to the full Council for appropriate budget amending action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17122-1, as amended and adopted therein, to provide authorization and direction to the Auditor and Comptroller to appropriate private gifts of funds (i.e., \$1 million from Ms. Joan Kroc) and other future gifts, with interest earnings added thereon.

Section 2. That the Auditor and Comptroller be and he is hereby directed to thereafter transfer said donation to the San Diego Festivals, Inc., for expenditure in accordance with its operating budget, with the Auditor and Comptroller maintaining an auditing overview thereon.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the
Charter of The City of San Diego.
