AN EMERGENCY ORDINANCE REPEALING ORDINANCE NO. O-17080 (NEW SERIES) ADOPTED APRIL 18, 1988, REGARDING CHAPTER X, ARTICLE 1, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE RELATING TO CONDITIONAL USE PERMITS.

WHEREAS, in order to provide continuity of regulations for certain conditional use permits governed by Section 101.0510, it is necessary to introduce and adopt this emergency ordinance which repeals Ordinance No. O-17080 (N.S.) before it becomes effective on October 17, 1988; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17080 (N.S.) adopted April 18, 1988, regarding Chapter X, Article 1, Division 5, of the San Diego Municipal Code be and the same is hereby repealed.

Section 2. This ordinance shall take effect immediately upon its adoption.

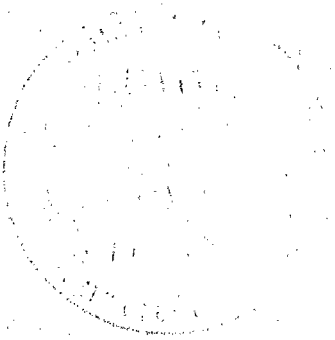
