AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3, DIVISION 15, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 103.1501 RELATING TO THE MID-CITY COMMUNITIES PLANNED DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 3, Division 15, of the San Diego Municipal Code be and the same is hereby amended by amending Section 103.1501, to read as follows:

SEC. 103.1501 BOUNDARIES

The regulations which follow shall apply in the areas of the Mid-City and State University Community Planning Areas in the City of San Diego, California, designated on Map Drawing Nos. C-706.1, C-706.2, C-712, and C-769, and described in the appended boundary description filed in the office of the City Clerk under Document Nos. 00-16576, 00-16661, 00-16646 and 00- 17176, and in the areas of the Greater North Park Community Planning Area in the City of San Diego, California, designated on Map Drawing Nos. C-738 and C-738.2, and described in the appended boundary description filed in the office of the City Clerk under Document Nos. 00-16972 and 00- 17173.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
