AN ORDINANCE AMENDING ORDINANCE NO. 0-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17122-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING ONE (1.00) BUILDING INSPECTION SUPERVISOR POSITION FROM THE CLASSIFIED SERVICE, CAUSING THE PERSONNEL AUTHORIZATION SCHEDULE OF THE BUILDING INSPECTION DEPARTMENT (1300), FIELD SERVICES DIVISION (13400), TO REFLECT THE BUILDING INSPECTION SUPERVISOR POSITION AS UNCLASSIFIED, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, in the fiscal year 1989 budget, the City Council approved the formation of a Combination Inspection Program (13461) in the Field Services Division (13400) of the Building Inspection Department; and

WHEREAS, this program provides the field compliance inspection of one and two family dwellings with the Building Code; and

WHEREAS, since the other programs within the Field Services
Division are managed by unclassified Building Inspection
Supervisors, the Building Inspection Director requested the Civil
Service Commission to exempt the new Building Inspection
Supervisor position from the Classified Service; and

WHEREAS, the position has significant management level responsibilities which fall within the managerial definition

contained in Charter section 117(a)17 and justify exemption from the Classified Service; and

WHEREAS, section 117(a)17 of the Charter provides that
"managerial employees having significant responsibilities for
formulating or administering departmental policies and programs"
may be exempted from the Classified Service by ordinance upon
first having been reviewed and commented upon by the Civil
Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on September 1, 1988 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, this action will amend the Appropriation Ordinance to exempt the new Building Inspection Supervisor from the Classified Service; and

WHEREAS, this action also recognizes that funds for said position have been appropriated in the fiscal year 1989 budget and that expenditure therefor from the Building Inspection Enterprise Fund (41300) is authorized; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on September 1, 1988, the new Building Inspection Supervisor position in the Building Inspection Department (1300), Field Services Division (13400) be and it is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 2. That Ordinance No. 0-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17122-1, as amended and adopted therein, by making and reflecting such exemption from the Classified Service of the Building Inspection Supervisor position in the personnel authorization schedule of the Building Inspection Department (1300), Field Services Division (13400).

Section 3. As a schedule of compensation for the above unclassified position recited in sections 1 and 2 hereof, funds appropriated and available therefor in the Building Inspection Enterprise Fund (41300), the salary rate set forth in Salary Rates 7.3, 7.4 and 7.5 of the Table of Classifications and Standard Salary Rates under Managerial Category B, contained in Exhibit C to Ordinance No. 0-17098 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
