ADOPTED ON NOV 21 1988

AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY DELETING THEREFROM THE BINATIONAL AFFAIRS DEPARTMENT (0160) AND ALL APPROPRIATIONS THERETO; TRANSFERRING THE POSITIONS AND SUCH APPROPRIATED FUNDS WITHIN THE GENERAL FUND 100, TO THE MAYOR'S OFFICE (0100); AUTHORIZING CONCURRENTLY THEREWITH POSITIONS OF BINATIONAL AFFAIRS OFFICER AND ASSISTANT BINATIONAL AFFAIRS OFFICER IN LIEU OF BINATIONAL AFFAIRS DIRECTOR AND ASSISTANT DIRECTOR; AND ESTABLISHING SALARY RATES THEREFOR.

WHEREAS, during the budget hearings on June 13, 1988, City Council approved in concept the transfer of Binational Affairs from the City Manager's jurisdiction to the office of the Mayor; and

WHEREAS, City Manager's Report No. 88-45, dated September 19, 1988, provides an in-depth discussion of the matter and the actions necessary to effectuate said transfer of duties; and

WHEREAS, it is necessary to amend the annual budget to transfer the Binational Affairs functions and duties to a newly created section in the Mayor's office, entitled "Mayor's Office of Binational Affairs"; and

WHEREAS, in connection therewith, it is necessary to transfer the positions and appropriations associated with the Binational Affairs function; and

WHEREAS, it is further necessary by separate legislative action, to amend the salary ordinance to delete the classifications of Binational Affairs Director and Assistant Director and replace them in lieu thereof, with a Binational Affairs Officer and Assistant Binational Affairs Officer as unclassified positions in the Managerial Category "C" and "B" respectively of Exhibit C to the salary ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, as amended and adopted therein, by deleting from said budget ordinance the Binational Affairs Department (0160).


Section 2. That the City Manager and City Auditor and Comptroller be and they are hereby directed to transfer all positions and appropriated funds associated with said Binational Affairs Department to the Mayor's Office of Binational Affairs within the Mayor's office (0100).

Section 3. That upon the effective date and amendment to the salary ordinance deleting Binational Affairs Director and Assistant Director, there shall be included, in lieu thereof, in such Mayor's Office of Binational Affairs one (1.00) Binational Affairs Officer in Managerial Category "C", Salary Rates 07.7,

0.7.8, and 07.9, and one (1.00) Assistant Binational Affairs
Officer in Managerial Category "B", Salary Rate 07.3, 07.4 and
07.5.

Section 4. This ordinance shall take effect and be in force
immediately upon its adoption after two public hearings, pursuant
to the authority contained in Sections 16, 17 and 71 of the
Charter of The City of San Diego.

AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17122-1, AS AMENDED AND ADOPTED THEREIN, BY DELETING THEREFROM THE BINATIONAL AFFAIRS DEPARTMENT (0100) AND ALL APPROPRIATIONS THERETO; TRANSFERRING THE POSITIONS AND SUCH APPROPRIATED FUNDS WITHIN THE GENERAL FUND 100, TO THE MAYOR'S OFFICE (0100); AUTHORIZING CONCURRENTLY THEREWITH POSITIONS OF BINATIONAL AFFAIRS OFFICERS AND ASSISTANT BINATIONAL AFFAIRS OFFICER IN LIEU OF BINATIONAL AFFAIRS DIRECTOR AND ASSISTANT DIRECTOR; AND ESTABLISHING SALARY RATES THEREFOR.

This ordinance amends the FY 1989 annual appropriations ordinance by deleting from the budget the Binational Affairs Department (0100) and all appropriations thereto; it further transfers the positions such as appropriated funds for that department to the Mayor's office of Binational Affairs within the Mayor's Department (0100). The ordinance further deletes all reference to Director and Assistant Director of Binational Affairs and authorizes, in lieu thereof, positions of Binational Affairs Officers and Assistant Binational Affairs Officer. Finally, it establishes salary rates for those two (2) new classes.
