ORDINANCE NUMBER O- 17185 (NEW SERIES)

ADOPTED ON NOV 21 1988

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTIONS 22.2201 AND 22.2202 RELATING TO THE DEPARTMENT OF BINATIONAL AFFAIRS AND AMENDING SECTION 22.1801 RELATING TO DEPARTMENTS OF THE CITY BY DELETING THEREFROM SAID DEPARTMENT OF BINATIONAL AFFAIRS.

WHEREAS, during the budget hearings on June 13, 1988, the City Council approved in concept the transfer of Binational Affairs from the City Manager's jurisdiction to the Office of the Mayor; and

WHEREAS, City Manager's Report No. 88-465, dated September 19, 1988, provides an in-depth discussion of the matter and the actions necessary to effectuate said transfer of duties; and

WHEREAS, it is necessary to repeal the Municipal Code sections relating to the Department of Binational Affairs and also delete said department from the departmental listing in the Municipal Code; and

WHEREAS, it is further necessary, by separate action, to amend the fiscal year 1989 budget to transfer the Binational Affairs functions and duties to a newly created section in the Mayor's Office, entitled "Mayor's Office of Binational Affairs";
NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Chapter II, Article 2 of the San Diego Municipal Code be and the same is hereby amended by repealing Sections 22.2201 and 22.2202, relating to the Department of Binational Affairs.

Section 2. That Chapter II, Article 2 of the San Diego Municipal Code is further amended by amending Section 22.1801 to delete from subsection b. the departmental title of Binational Affairs.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
