AN ORDINANCE AMENDING ORDINANCE NO. 0-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17122-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING ONE (1.00) DEPUTY DIRECTOR POSITION IN THE WASTE MANAGEMENT DEPARTMENT (510) FROM THE CLASSIFIED SERVICE; AMENDING THE PERSONNEL AUTHORIZATION SCHEDULE OF THE WASTE MANAGEMENT DEPARTMENT, PLANNING AND ADMINISTRATION DIVISION (51110) TO REFLECT THE DEPUTY DIRECTOR POSITION AS UNCLASSIFIED, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the City Council authorized an additional Deputy
Director position in the Waste Management Department for fiscal
year 1989; and

WHEREAS, said position was created to accommodate a Planning and Administration Division within the Waste Management Department; and

WHEREAS, the position has significant management level responsibilities which fall within the managerial definition contained in Charter section 117(a)17 and justify exemption from the Classified Service; and

WHEREAS, it has been requested that the newly created Deputy
Director position be exempted from the Classified Service and
placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that
"managerial employees having significant responsibilities for
formulating or administering departmental policies and programs"
may be exempted from the Classified Service by ordinance upon
first having been reviewed and commented upon by the Civil
Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on August 11, 1988 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on August 11, 1988, the new Deputy Director position in the Waste Management Department (510), Planning and Administration Division (51110) be and it is hereby exempted from the Classified Service of The City of San Diego.

Section 2. That Ordinance No. 0-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17122-1, as amended and adopted therein, by making and reflecting such exemption from the Classified Service of the Deputy Director position to the personnel authorization schedule of the Waste Management Department (510), Planning Administration Division (51110).

Section 3. As a schedule of compensation for the above unclassified position recited in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, contained in Exhibit C to Ordinance No. 0-17098 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
