AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF COUNCIL DISTRICT 8 (028) BY EXEMPTING ONE (1.00) COUNCIL REPRESENTATIVE I POSITION FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, Council District 8 has added in Fiscal Year 1989 one (1.00) Council Representative I position to its personnel allocation; and

WHEREAS, it has been requested that the newly authorized Council Representative position be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on August 11, 1988 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said reclassification; NOW, THEREFORE

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission in its memorandum to the City Council, dated August 11, 1988, attached hereto as Attachment A, the Council Representative I position authorized in Council District 8 (028) for fiscal year 1988-89 is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 2. That Ordinance No. O-17122 (NEW SERIES), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122, as adopted and amended therein, by amending the personnel authorization schedule for Council District 8 (028) to reflect therein the Council Representative I position as being in the Unclassified Service.

Section 3. As a schedule of compensation for the above unclassified position created in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.0, 7.1 and 7.2 of the

Table of Classifications and Standard Salary Rates under
Managerial Category A, contained in Exhibit C to Ordinance No.
O-17098 (NEW SERIES), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force
immediately upon its passage after two (2) public hearings
pursuant to the authority contained in sections 16, 17 and 71 of
the Charter of The City of San Diego.

SUBJECT: UNCLASSIFIED EMPLOYEES - CHARTER SECTION 117

On August 11, 1988, the Civil Service Commission reviewed a request from Councilmember Filner to exempt a new Council Representative position from the Classified Service.

Charter Section 117 states that the Unclassified Service shall include "Managerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council."

Upon review of the duties and responsibilities to be performed, the Commission finds that this position does meet the criteria of the Charter and supports exemption from the Classified Service. If additional information would be of assistance in your consideration of this matter, staff is available to respond with details as necessary.
