AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY ESTABLISHING CAPITAL IMPROVEMENT PROJECT NO. 52446, "I-805/MIRA MESA BOULEVARD INTERCHANGE,"; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$60,000 FROM FUND NO. 10506, TO C.I.P. NO. 52446, FOR THE PURPOSE OF FUNDING C.I.P. NO. 52446, "I-805/MIRA MESA BOULEVARD INTERCHANGE."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, as amended and adopted therein, by establishing Capital Improvements Project No. 52446, entitled "I-805/Mira Mesa Boulevard Interchange" for the purpose of funding preparation of the project report and NEPA Environmental Document for the I-805/Mira Mesa Boulevard Interchange.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$60,000 from Fund No. 10506, to C.I.P. No. 52446, "I-805/Mira Mesa Boulevard




