R-270952 TO PLACE THE NEWLY CREATED CLASS IN THE TECHNICAL REPRESENTATION UNIT; AND AMENDING RESOLUTION NO. R-270951 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASS AS ELIGIBLE FOR PREMIUM RATE OVERTIME BY PLACING IT IN GROUP A OF SAID OVERTIME ELIGIBILITY RESOLUTION NO. R-270951.

WHEREAS, during the most recent salary negotiations between the City and the San Diego Municipal Employees Association, it was mutually agreed upon that the City Manager would recommend to the Civil Service Commission that a new class of Fire Dispatcher be created effective December 30, 1988 for the Dispatcher positions in the Fire Department; and

WHEREAS, these positions are currently classified as Dispatcher II, and

WHEREAS, the agreement further recommended that the salary of this new class be established at approximately 5% above the current Dispatcher II salary range; and

WHEREAS, at their November 3, 1988 meeting, the Civil Service Commission approved the creation of a new class of Fire

Dispatcher with a salary range of \$1,858 - \$2,240 per month effective December 30, 1988 through June 30, 1989, a salary range approximately 5% above that of Dispatcher II; and

WHEREAS, it is also recommended that this class be eligible for premium rate overtime under the same conditions as other classifications in Group A of the Addendum to Personnel Manual Section H-4, Overtime, and included in this group are those classes designated as nonexempt from the overtime provisions of the Fair Labor Standards Act; and

WHEREAS, it is recommended that this class be placed in the Technical Bargaining Unit; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17098 (NEW SERIES), entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1988-89" be and the same is hereby amended by amending Exhibit B thereto by creating and adding a new class, entitled "FIRE DISPATCHER" in the Communications Occupation Group at salary rate number 46.4.

Section 2. That Exhibit A-2 of the above-cited ordinance be amended to include a new salary rate number 46.4, ranging from \$1,858 to \$2,240 per month, at rates and steps as set forth in Attachment A hereto.

Section 3. That Resolution No. R-270952, be and it is hereby amended to place the newly created class of FIRE DISPATCHER in the Technical Representation Unit.

Section 4. That Resolution No. R-270951, be and it is hereby amended by approving and declaring the newly created class as eligible for premium rate overtime and placing said newly created class in Group A Overtime Eligibility.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage; provided however, that the position created in Section 1 above shall be in effect on December 30, 1988 for all purposes of processing, certifying, and selection.
