AN ORDINANCE INCORPORATING A PORTION OF THE SITE FROM A1-1 (HRO) LOCATED SOUTHERLY OF ARROYO SORRENTO ROAD AND EL CAMINO REAL AND DESCRIBED AS A PORTION OF LOTS 2, 3 AND 4 OF SECTION 30, TOWNSHIP 14 SOUTH, RANGE 3 WEST, SBM, IN THE SORRENTO HILLS COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-IP (HRO) ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0435.1, AND REPEALING ORDINANCE NO. 0-10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, AND REPEALING ORDINANCE NO. 0-12658 (NEW SERIES), ADOPTED MAY 22, 1979, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of the site from A1-1 (HRO) located southerly of Arroyo Sorrento Road and El Camino Real and described as a portion of Lots 2, 3 and 4 of Section 30, Township 14 South, Range 3 West, SBM, in the Sorrento Hills Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-IP (HRO)" on Zone Map Drawing No. B-3874, filed in the office of the City Clerk as Document No. 00-17108, be, and it is hereby incorporated into M-IP (HRO) Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0435.1.

Section 2. That Ordinance No. 0-10936 (New Series), adopted October 5, 1972, and Ordinance No. 0-12658 (New Series), adopted May 22, 1979, of the ordinances of The City of San Diego be and they are repealed insofar as the same conflict herewith.

Section 3. This ordinance shall not become effective until thirty (30) days from and after its passage or until thirty (30) days from and after this rezoning is certified, as submitted, as a Local Coastal Program amendment by the California Coastal Commission, whichever date later occurs. If the rezoning is not certified, as submitted, by the California Coastal Commission, this ordinance shall not become effective.
