AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, TO ESTABLISH A SPECIAL FUND TO BE ENTITLED "URBAN CONSERVATION CORPS FUND," (NO. 10590), SAID FUND TO EARN AND BE CREDITED WITH INTEREST EARNINGS IN PROPORTION TO TOTAL EARNINGS RECEIVED BY THE CITY; AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO ACCEPT FOR DEPOSIT AND TO DISBURSE MONIES FROM THIS FUND, AS DIRECTED.

WHEREAS, at the direction of the City Council, the City Manager is in the process of forming an Urban Conservation Corps for the community's young people who are out of school and without employment; and

WHEREAS, the Corps will be established to serve approximately 80 individuals, and will have as a goal the placement of these individuals in full-time employment in the private sector; and

WHEREAS, in order to facilitate fund raising, it is necessary to establish a special fund to account for monies raised and expended on this project; and

WHEREAS, the consultant approved previously by the City Council for this purpose will have the responsibility of fund raising for the project; and

WHEREAS, funds raised will be used for expenses associated with the Corps development and start up; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1 as amended and adopted therein, to establish a special fund to be entitled "Urban Conservation Corps Fund," (No.10590), said fund to earn and be credited with interest earnings in proportion to total earnings received by the City.

Section 2. That the Auditor and Comptroller be and he is hereby directed to accept for deposit into and disburse monies from this fund as directed.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
