AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY ACCEPTING, ADDING AND APPROPRIATING TO THE TOTAL BUDGET A REPAYMENT OF \$100,000 FROM THE REDEVELOPMENT AGENCY AND DIRECTING THE AUDITOR AND COMPTROLLER TO ALLOCATE SAID FUNDS TO THE GENERAL FUND 100, SPECIAL PROMOTIONAL PROGRAMS (91500) FOR FURTHER ALLOCATION TO THE NEW HERITAGE THEATRE, INC., DBA, GASLAMP QUARTER THEATRE.

WHEREAS, the City has previously loaned TOT funds to the Redevelopment Agency (herein "Agency") to accomplish and fulfill its redevelopment responsibility; and

WHEREAS, the Agency now proposes to repay to the City, the sum of \$100,000 previously loaned, said funds to come from the Columbia Redevelopment Project; and

WHEREAS, such repayment represents principal and interest on Transient Occupancy Tax Funds loaned to the Agency and are available in the fiscal year 1988-89 budget; and

WHEREAS, it is requested by the Agency, via recommendation from CCDC, that the amount repaid be reallocated for the purpose of providing additional funds to the Gaslamp Quarter Theatre, presently set forth in Special Promotional Program funding; and

WHEREAS, it is necessary to amend the annual appropriation ordinance to accept said \$100,000 to the total budget and reallocate as above recited; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17122-1, as amended and adopted therein, by accepting the sum of \$100,000 from the Redevelopment Agency representing payment of principal and interest on Transient Occupancy Tax Funds loans made to the Agency in the Columbia Redevelopment Project and directing the Auditor and Comptroller to appropriate and allocate said funds to the General Fund 100, Special Promotional Programs (91500) for further allocation to the Gaslamp Quarter Theatre.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
