ADOPTED ON JAN 23 1989

AN ORDINANCE AMENDING CHAPTER III, ARTICLE 5, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 35.0104 RELATING TO TRANSIENT OCCUPANCY TAX EXEMPTIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Chapter III, Article 5, Division 1, of the San Diego Municipal Code be and the same is hereby amended by amending section 35.0104 to read as follows:

SEC. 35.0104 EXEMPTIONS

No tax shall be imposed where the rent is at the rate of twenty dollars (\$20.00) a day or less. The exemption in this section applies only to a single individual occupying a single room or where the total rent charged for a room is twenty dollars (\$20.00) a day or less or where the accommodations rented are in a dormitory and the rent for each transient is twenty dollars (\$20.00) a day or less.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


