WHEREAS, the City Manager, by and through the Library Department, was notified in October that the application for the two (2) videocassette recorders had been approved; and


WHEREAS, it is now appropriate to authorize acceptance of said gift from the Carnegie Corporation; NOW, THEREFORE,
