WHEREAS, each year since Fiscal Year 1984, the San Diego Public Library has received SB 358 grant funding, which is allocated to enhance the Library's operating budget; and

WHEREAS, the funds are generally received at the beginning of the calendar year and are deposited by the City until the start of the next Fiscal Year when they are then expended; and

WHEREAS, during this five to six month period, the grant funds earn interest which is added to the fund balance, and is available for use by the Library but must be appropriated by Council; and

WHEREAS, at the end of each fiscal year there are usually some allocated SB 358 monies which have not been expended, and revert to the fund balance, and are available for appropriation and expenditure in the following fiscal year; and

WHEREAS, the City Auditor and Comptroller has authorized the transfer of \$148,000 from SB 358, Non-appropriated Fund Balance (Fund No. 19207) to the Library Department's Fiscal Year 1988, SB 358 operating budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$148,000 from the SB 358,

Non-appropriated Fund Balance (Fund No. 19207) to the Library

Department's Fiscal Year 1988, SB 358 operating budget.

BE IT FURTHER RESOLVED, that the City Council authorize the expenditure of said amount as recommended on City Manager's Report No. 87-596.
